- **The Championship will begin at 900 am on both days until dusk with a safety meeting
starting at 830 am beforehand.**
- **The firing line is 20 benches with expected 4-5 relays.**
- **The competition, course of fire, trophies, points, rules including rifle/equipment will conform to the
IBS rule book.**
- **Light/Heavy bench assignment and rotation will match last years Nationals in St Louis***
 1. **All Light Guns will be weighed Saturday morning before the first relay begins.**
 2. **All competitors will rotate 5 benches after every pair of targets**
 3. **On the second day, the Heavy gun Competitors will start the same bench they ended on the day
before.**
 4. **All relays will shift by 2 on the second day. For example, if your Light Gun relay was 7 on
Saturday, your Heavy Gun relay will be 9 on Sunday.**
 5. **All this information will be on the Match card provided at check-in including the Competitor
Number. Please keep these handy during the match and especially for the lunches.**

I understand the personal assistant can not be a competitor on the same relay on which I am competing. This release shall be valid starting from date executed for as long as participant either (1) participates in any activities associated with or (2) is on or near the premises of the above Club. If participant is a minor, Parent or Guardian executes this agreement on behalf of himself/herself as well as the minor child or legal ward. (Minors will be required to complete a new form at age 18 or upon change of guardianship.)
