- MSSA will be open for practice and check-in on Wednesday 9/14/2022 from 12:00 p.m. to 5:00 p.m. and Thursday 9/15/2022 from 8:00 a.m. to 5:00 p.m.
- You must present your current IBS or Williamsport membership card at check in. You can join the IBS onsite at check in.
- The Championship will begin at 8:00 a.m. Friday 9/16/2022, safety meeting starts at 7:30 AM.
- ➤ The competition will conform to the IBS rule book including proof of IBS membership, course of fire, trophies, points, and rifle/equipment specifications etc.
- > All Light Guns will be weighed at check in.
- ➤ The firing line has 24 benches with a 6-bench rotation.
- ➤ The 6-bench rotation will be after every pair of targets fired in Light Gun on Friday.

  On Saturday Heavy Gun competitors will start on the same bench that they ended on the day before, the same 6 bench relay rotation will apply for Heavy Gun.
- During match rotations, bench gear must be kept in the staging area (your pop-up) or on the concrete slab in front of the benches. NO gun cleaning will be allowed on the picnic tables or under the pavilion.
- > Rifles (bolts removed) may be placed on the wooden tables behind the benches.
