891 A Match shall consist of a one, two, or three target aggregate, number of targets to be shot for a 892 Match will be determined by the individual Clubs, and submitted with their Match contract and

893 approved by the IBS Match Schedule Chairman before the start of their season.

894 Shooters will compete against the same shooters for each of the targets to be included in the

904 **some** reason a period of more than one minute elapses between the end of the sighters only and the

905 command commence fire, an additional minute is allowed for an additional sighter shot.

906 In the event a shooter cannot fully utilize the last minute of the sighter only period due to no fault of 907 theirs (usually a target problem), they need to notify the Range Officer by holding their arm up 908 and asking for attention. The range officer will direct the balance of the shooters to continue the

sighter period and fire their record rounds per normal procedures. The shooter that could not

910 finish the sighter period or record target will remain seated until all other shooters have

911 completed their record targets. At that point the Range Officer will direct the target crew to

- 912 correct the target problem. The shooter will then be allowed a one minute sighter only period and go
- 913 directly to the record round per normal procedures. All other shooters on that relay will remain

courteous and seated until the shooter with the problem has completed firing and the

915 Officer indicates it is safe to clear the benches.

In less than one (1) minute the Range Officer will confirm that all Record Targets are in the air.

985 Note: If more than one (1) minute elapses after Cease Fire for the sighter period and Commence

986 Fire for the Record period, shooters will be given one (1) additional minute for sighters.

987

988 END OF RECORD PERIOD – When time has expired or when the last shooter has finished

989 his/her string of fire, whichever shall be earlier, the Range Officer will give thefollowing

990 commands: "CEASE FIRE, CEASE FIRE THIS ENDS YOUR RECORD PERIOD. REMAIN

991 **SEATED. REMOVE AND SHOW BOLTS.**" This applies anytime that a "CEASE FIRE" is 992 called and the benches have to be cleared to allow target crews or others downrange.

993

At this point the Range Officer will visually inspect the firing line, with help from appointed

995 Safety Officers, who will signal the Range Officer with a "thumbs up" sign that all bolts are out.

**LR2** – This agenda item is to change the color of the IBS 600 yard targets to red from the current blue we are using. Clubs will be allowed to use all of the blue targets they have remaining until they are gone. Any record shot on either target in 2025 will be recognized.

**LR3** - Returning to the Sighter Plate during Record Fire

The Purpose of this Agenda Item is to combine the Sighter and Record Fire portions together and allow the shooter to return to the sighter plate at any point during Record Fire. Note that it also eliminates the language regarding the use of pits.

Remove the language from Lines 1025 through 1054 and replace with the following language in Red to denote it is a change:

All shooters will have a ten (10) minute period to fire five (5) shots for record on their target and as many sighters on the sighter plate as they wish. They may return to the sighter plate at any point during this period.

If a target should come loose during the record fire, the shooter shall raise their hand and draw the attention of the Range Officer. If the shooter has not completed placing their five (5) record shots on target, the Range Officer will direct the Target Crew to reattach or replace the target at the shooter's discretion, after the rest of the shooters have completed their record target, and the shooter shall be allowed six (6) minutes to complete or re-shoot their target. Additionally, if this target issue occurs during firing at the first target, the shooter may choose to shoot at the other target and notify the Range Officer to simply replace the target and shoot it during the Record Fire period for the second target.

Of further note: if this Agenda Item passes it will require appropriate changes to the following section; Course of Fire Range Commands for 600 Yard Discipline. Those changes shall be drafted by the 600 Yard Committee and be subject to the approval of the Executive Board.

LR4 - Eliminate disqualification for missing and additional shots on target Proposal:

Shooters who have fewer than the required number of shots on target will be assessed a 2-inch penalty for each missing shot and receive a score of zero. Competitors who place more than the required number of shots on target will receive the largest possible group and the lowest score. Procedures for crossfire will remain the same.

Rationale:

The current rule of disqualifying shooters for missing shots or additional shots is overly punitive. Instituting a penalty per missed shot provides a fairer and more logical approach for competitors.

Procedure:

**RB1** – This agenda item to not allow any other organizations memberships to be valid at ANY IBS sanctioned tournament. We will remove all language in Group, Score, 1,000 yard and 600 yard rulebooks that allows any other organizations membership card to be recognized as a valid membership to compete in an IBS match.

**RB2** – Purpose – this is to eliminate the restrictions on officials at our National tournaments. Anything in **RED** will be eliminated and the new language to replace it is below in black.

Group and Score Rulebooks lines 174 – 177

No official, except Referees, shall participate as contestants in a Championship Tournament in which he/she is an official. At the discretion of the host IBS club, a Range Officer may shoot as long as he/she is not responsible for providing Range Officer supervision for a Match in which he/she is actually shooting.

Long Range Rulebook lines 310 – 311

The Director or his/her designated representative may also be a shooter. The exception to this rule is that in a National Championship he/she may not be a shooter.

Group and Score Rulebooks

**Any valid IBS member can** participate as contestants in a Championship Tournament in which he/she is an official.
