This risk includes, but is not limited to, my being in the presence of and/or using firearms and includes but is not limited to property damage, injury, or death resulting from the dangers or conditions that are an inherent risk of firearms activity.

By signing this RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, I UNDERSTAND AND KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, EVEN IF ARISING FROM THE CARELESSNESS, RECKLESS, NEGLIGENCE OR LEGAL LIABILITY of those persons released from liability below, and assume full responsibility for my participation. I understand that there may be other risks, as well, and I agree to assume them; I am not relying on the above named club to list all possible risks for me.
3. I feel that the possible benefits to myself in this rifle tournament are greater than the risks assumed.

I understand the personal assistant can not be a competitor on the same relay on which I am competing. This release shall be valid starting from date executed for as long as participant either (1) participates in any activities associated with or (2) is on or near the premises of the above Club. If participant is a minor, Parent or Guardian executes this agreement on behalf of himself/herself as well as the minor child or legal ward. (Minors will be required to complete a new form at age 18 or upon change of guardianship.)
