When received and if properly signed, one copy will be sent to I.B.S. headquarters, and one copy will be retained by the Match Chairman.

- 1) The \_ (club) agrees to assume all liabilities that may be incurred at rifle matches held on the date(s) listed herein and to guarantee I.B.S. against any liability incurred at such matches.
- 2) The club agrees to abide by all applicable rules of I.B.S. and for **Group Matches** to have a workable moving backer target and Stationary backer in operation in all matches, single yardage score matches excepted. **An operating P.A. System and an Air Horn or loud buzzer is also required.**
- 3) The club will not dispense alcoholic beverages at a location easily accessible to the loading area or the firing line until the day's shooting is completed.
- 4) The club agrees to supply each registered competitor, IBS Webmaster, and the 2<sup>nd</sup> Vice President (Awards Chairperson) a copy of the complete official results bulletin for all matches and aggregates within four weeks after the match date; and further agrees to mail to I.B.S. Headquarters within four weeks after match dates: (a) a copy of the complete official results bulletin, (b) the completed registration and equipment data cards for each registered competitor, and (c) the registration fees due to I.B.S.
- 5) I.B.S. agrees to recognize any record groups, aggregates, or scores shot at matches held on the dates listed herein, after being confirmed by official measurement and provided all the rules of I.B.S. have been adhered to.
- 6) The I.B.S. Director from the host club agrees to appoint three (3) official referees who must be IBS members in good standing (who may be competitors). Two (2) of the official referees should be from outside the area to serve on the three-person committee for the matches on the dates listed herein.

**I.B.S. FEES---**The following fees must be paid, or a shoot will not be recognized as a registered shoot:  
**\$2.00 per shooter per registered Tournament.** The fees must be paid whether the club collects them from the competitor or not.  
**I.B.S. requires that the club have all competitors produce their current IBS membership identification.**  
In absence of a membership card, reasonable proof of membership is required.  
Cards from other countries affiliated with I.B.S. will be honored.
